FELLOWSHIPS AND PRIZES

FELLOWSHIPS

The IUPS Fellowships

The International Union of Physiological Sciences (IUPS) has granted PANAM 2023 USD 4,500, to be used for waiving (full or partial) registration fees for students and early career researchers (ECR).

- The budget will be allocated by the PANAM Organising Committee.
- A total of 93 fellowships covering 50% of the registration fees (Early bird deadline, August 31, 2023) will be granted. Two thirds of the total fellowships budget will go to students and one third to ECR. Students will receive USD 44 and ECR USD 61 as reimbursement. The total number of fellowships will be 68 Students and 25 ECR.
- Recipients will be balanced across countries and genders.
- The awardee must have successfully submitted an abstract, which must be accepted by the international scientific committee (deadline for abstract submission is October 15, 2023).
- Participants interested must proceed with registration at the conference platform by the Early Bird registration deadline (August 31, 2023).
- The list of beneficiaries will be announced by November 20, 2023.
- The benefited participants will be reimbursed in cash in Chilean Pesos (CLP) at the conference front desk on November 30, from 14:00 to 15:00.
- The benefited participants are requested to have attended the full conference.

The International Union of Physiological Sciences (IUPS) has granted PANAM 2023 with USD 1,500 to be used for five (5) rewards of USD 300 each for the following categories:



- Two (2) best poster presentations
- Two (2) best communications
- One (1) best report of the meeting on social media*

*The "best report of the meeting in social media" award

IUPS awards the best series of blogs or posts on Facebook, Instagram or other social media explaining with their own words and pictures scientific and social highlights of the congress, the appeal and value of physiology, IUPS, and PANAM conference for the public and why it is nice to be a physiologist.

The goal is to apply originality to reach out to other young scientists and friends from different professions and broadcast PANAM, Physiology, and IUPS.

- The reports (video, text, or a mix) can be submitted individually or as a team.
- The reports must be done by someone under 30 years old.
- A jury will be formed to elect the best and most convincing individual or team.
- The budget will be allocated by a jury composed of the PANAM Organising Committee and IUPS members.
- Recipients are to be balanced across countries and sexes.
- The awardee must have successfully submitted an abstract, which must be accepted by the international scientific committee (the deadline for abstract submission is October 15, 2023).
- Participants interested must be registered as attendees presenting or not an abstract at the conference (the Early Bird registration deadline is August 31, 2023; the deadline for abstract submission is October 15, 2023).
- The benefited participants will be announced at the Award Ceremony on November 30, 2023, at 13:30.
